Reduced Fees Under AB540

AB540 is a California State Law that exempts certain students who are not residents of California from paying non-resident tuition at California Community Colleges and California State Universities.

Students who meet all of the following requirements are eligible.

- You attended a combination of California high school, adult school, and California Community College for the equivalent of three years or more or attained credits earned in California from a California high school equivalent to three or more years of full-time high school course work and attended a combination of elementary, middle and/or high schools in California for a total of three or more years.
- 2. You graduated from a California high school or attained the equivalent (e.g. CA-issued GED or California High School Pro ciency Exam) prior to the start of the term, completed an associate degree from a California community college, or completed the minimum transfer requirements from a California community college to a California State University or the University of California.
- 3. You must currently be registered at an accredited institution of higher education in California.
- 4. You completed a California Nonresident Tuition Exemption Request form.
